

# **DEE KENNEDY PROJECT**

**Boston Municipal Court – Dorchester Division** 



#### PURPOSE

The Dee Kennedy Project (DKP) helps justice-involved adults find supportive pathways to exit commercial sexual exploitation (CSE). The DKP offers a variety of services - from offering a supportive ear, to speaking with a peer advocate and recovery coach, to helping individuals to achieve short- and long-term goals at their own pace. The DKP offers advocacy, peer support, connection to social and clinical services, and interdisciplinary collaboration to best serve and assist survivors of CSE as they navigate the criminal justice system.

The framework for the DKP is to provide trauma-informed and client-centered interventions provided by a Peer Advocate/Recovery Coach working with North Suffolk and a supporting team.

Cases are discussed during weekly team meetings, and each referral is assigned an ID number to ensure anonymity and confidentiality when the case is being discussed outside of the Advocate and Project Coordinator.

# ELIGIBILITY

In order to be eligible for the DKP, the individual must have a history or current involvement with CSE, be 18 years of age or older, and have justice involvement with any Boston Municipal Court (e.g., open cases, warrants, on probation/parole, filing for a restraining order, etc.).

Referrals can be made by contacting **Sandra Andrade**, Peer Advocate/Recovery Coach, via email or phone and providing the referral's name, date of birth, contact information, next court date, charges, and whether it is safe to leave a voicemail on their phone. (Note: Currently DKP is only accepting referrals with justice-involvement in Suffolk County.)
